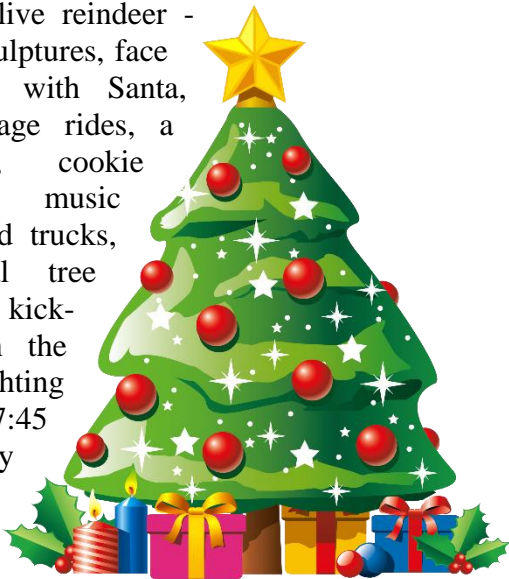

## AIRPORT MASTER PLAN UPDATE

As part of Heber City's efforts to update the existing Airport Master Plan for Heber Valley Airport, the City has launched [HeberValleyFlightpath.com](http://HeberValleyFlightpath.com). The new website contains vital information about the Airport Master Plan update process and will be a key way to exchange information with the community. The Flightpath website will be used by the public, the project committees, and the City Council as decisions are made about the future of Heber Valley Airport.

An Airport Master Plan is a comprehensive study that describes an airport's short, medium, and long-term plans, and this update will help Heber City determine what should happen at the airport over the next 20 years. Named "Flightpath," the Airport Master Plan update for Heber Valley Airport is expected to take between 18 and 24 months. Work on the Airport Master Plan update is just beginning: The City's engineering firm, T-O Engineering, Inc., has started to collect data on the existing features of the airport, and the first public meeting will be in January 2020.

The new Flightpath website contains an events calendar, a Documents page that offers instant access to download project files, and a Frequently Asked Questions page that provides answers to queries about the project and its process. The FAQs, as well as the project Updates page, will continue to provide new information as the Airport Master Plan update progresses.

## TO FLUSH OR NOT TO FLUSH?

Our sewer crew would like to remind the community to please refrain from flushing ANYTHING aside from flushable toilet paper and human waste down the toilet. Sanitary products marked "flushable" are NOT truly flushable – regardless of what manufacturers indicate in advertisements and on package. Please be advised that reusable/disposable wipes are already outlawed in a large number of communities, and they quickly become the



number one cause of sewer lateral and main line backups. These items, including wipes, feminine products, etc. clog our sewer system causing severe back-ups and property damage, as does grease poured down the drain.

Please help us keep our sewer system in good working order and free of blockages by discarding such items properly!

## SNOW REMOVAL AND STREET PARKING

Our snowplowing crew would like to remind Heber City residents that the snow season is upon us and to please keep roadways clear of automobiles, trailers, motor homes, basketball standards, and other roadblocks and debris that may impede snow removal operations.



**City code 10.16.040: Parking During Snow Cleanup Periods;** parking on the street between November 15<sup>th</sup> – April 1<sup>st</sup> may result in a parking ticket and/or towing.

In order to ensure the safety of the community, we need to work together to keep streets as free as possible from snow and ice. Cars and other items along the side of the road cause obstructions to plows and impede our ability to fully remove snow and ice in the area, thus causing potential hazards to pedestrians and drivers.

Additionally, we remind residents that it is a violation of City code to push or pile snow into or across street right-of-ways when removing snow from their own lots (refer to City code 12.06.040: Sidewalk Cleaning Enforcement). We appreciate the public's cooperation in helping to keep our roads safe & clear of snow!
