ORDINANCE 2021-17

AN ORDINANCE AMENDING THE *SCHEDULE OF COMPENSATION* AS ADOPTED AND PART OF SECTION 2.02.010 OF THE HEBER CITY MUNICIPAL CODE, COMPENSATION FOR ELECTED OFFICIALS AND STATUTORY OFFICERS.

BE IT ORDAINED by the City Council of Heber City, Utah, that the Schedule of Compensation adopted as part of Section 2.02.010 of the Heber City Municipal Code, *Compensation for Elected Officials and Statutory Officers* is amended as set forth in attached Exhibit A. This Ordinance is amended to reflect the City Council’s decision to increase the compensation for elected and statutory officers effective July 1, 2021.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance or Exhibit is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this Ordinance and Exhibit.

If any provisions of the Heber City Code heretofore adopted are inconsistent herewith they are hereby repealed.

To the extent that any ordinances, resolutions, or policies of Heber City materially conflict with the provisions of this Ordinance, they are hereby amended to comply with the provisions hereof.

These employees receive merit and cola increases annually based on city-wide increases for non-statutory employees. The City Council annually evaluates the City Manager, Chief of Police and City Attorney for any merit increases.
